“SYMPHONY” - INFORMATION AND CONDITIONS

IMPORTANT

A completed booking form and full payment (£9 per person) must be received by the office **within 3 weeks** to secure the booking. This charge is non-returnable in the event of cancellation.

You are requested to arrive at the moorings for a prompt departure at 10.00 am unless otherwise agreed in advance. **In the event of late arrival please ring “Symphony” on 07813 205809.** The trip ends at approximately 3.00 pm. You must make your own travel arrangements to/from the moorings. The Trust may have to amend/cancel a booking due to unforeseen circumstances, in which case an alternative date will be offered.

The Trust cannot be responsible for the care of passengers whilst ashore and whilst boarding the boat and it is therefore essential that at least one carer is present at the base on or before the arrival of any of the passengers and until the last of the passengers has left the base after the trip.

CREW AND HELPERS

The Trust has a Certificated Skipper and usually three Trust Volunteer Crew per trip.

NUMBERS

Your party **cannot exceed 26 passengers** (as licensed by the Maritime & Coastguard Agency). This total includes all helpers and drivers. If your group is less than 26, it may be necessary to share the boat with another similar group.

(i) WHEELCHAIRS

Groups may include a maximum number of 13 standard wheelchairs. If you are bringing non-standard wheelchairs then please contact the office before returning the booking form to ensure that there is sufficient availability.

(ii) CATERING/LUNCHES

Tea, coffee, soft drinks and biscuits are provided by the crew free of charge. There is space for groups to leave their lunches on arrival, and a fridge is available for storage of medicines etc. If you require the use of a microwave to heat food etc please advise at the time of booking.

NB. If a group wishes to stop at a pub for lunch, the office must have advance notice of a minimum of two weeks prior to the date of the trip. A prompt 10 am start is essential in this case. Whilst we will endeavour to arrange a pub stop for a group, no guarantee can be made that it will be wheelchair accessible as we are totally reliant on the river not being in flood, which can happen even in the height of summer!

PLEASE NOTE THAT THERE ARE NO DISABLED TOILET FACILITIES AT THE ROSE & CROWN AT ZOUCHE BUT THERE ARE OF COURSE DISABLED TOILETS ON BOARD. PUB LUNCHES ARE NOT AVAILABLE AT WEEKENDS

INSURANCE

Public liability cover has been taken out by the Trust. Passengers must, however, be responsible for their own personal possessions and medical requisites. Whilst not medically responsible, the Trust does reserve the right to get emergency medical assistance if the Skipper deems it necessary. An extensive First Aid case is carried.
