## “MELODY”

“Melody” is a narrow boat, 65’ long and 6’ 6” wide, equipped to take families, or groups of friends, with a disabled or seriously ill member on holidays and is designed to take manual wheelchairs only - not electric. She has the following features:-

- 1) Two toilets and one shower.
- 2) Two electric hydraulic lifts for easy access to forward and rear decks.
- 3) Telephone for use in case of emergencies only: 07850 565955. Use is restricted to calls to the Trust, the Emergency Services and River Canal Rescue Ltd. in case of breakdown.
- 4) A First Aid case is provided.
- 5) A fully-equipped galley with cooker, fridge, sink unit, cupboards, and all necessary utensils, crockery, cutlery etc., although you should bring any special needs utensils.
- 6) Side hatches can be opened when required to enable even those who are in bed to enjoy the atmosphere of the water, sun and countryside. The fore and rear deck areas are large and easily accessible to everyone, including those in wheelchairs. An awning with transparent side panels is provided over the foredeck for shade or additional shelter.
- 7) A television with DVD player and two radio cassette players are provided.
- 8) The floor is fully carpeted to provide a non-slip and warm surface.
- 9) Radiators throughout provide central heating.
- 10) Forward cabin windows are low level for easy viewing.
- 11) The boat sleeps up to eight passengers depending on the nature of disability (see layout plan) and the age of the passengers, two of whom must be able-bodied adults. Limited storage is included for personal belongings, and we suggest that suitcases are unpacked on the boat and the cases left in the car in order to save valuable storage space.
- 12) Bedding is provided and consists of an under-blanket, bottom sheet, continental quilt and cover, two pillows and pillow cases per person, plus an adequate supply of rubber sheets. Please bring extra bedding e.g. draw sheets, blankets, if required. Towels are provided, but not tea-towels.
- 13) Life-jackets/buoyancy aids are provided by the Trust.
- 14) Lights are provided to all berths.
- 15) The electrical supply is 12v but a separate generator can supply 240v for short periods for nebulisers etc. There is also a 150w inverter for providing 240v direct from the boat’s batteries, but there is no facility for charging electric wheelchairs.

### PLEASE NOTE:

- 1) No smoking is permitted on the boat, other than on the outside deck.
- 2) Regrettably we are unable to allow any pets - even guide dogs - because of the possible effects on future passengers with allergies.

### DATES AND TIMES

The boat is available from 11 am on Saturday until 10 am the following Friday. If you are going to arrive late on the Saturday morning it is **most important** that you telephone us on 01509 265590 from 9.00 am onwards to let us know your expected time of arrival. There is a good main-line train service to Loughborough where taxis are available.

At the end of your holiday the boat must be vacated by 10 am so that we can start to clean and prepare the boat for the next trip.

### CATERING

It is essential for passengers to bring any special needs utensils e.g. cups with spouts etc. as well as disposable paper towelling and tea towels.

### INSURANCE

The boat is insured by the Trust but it is the responsibility of the passengers to ensure that all members of the party have adequate personal insurance cover for the period of the holiday. Hirers are also strongly advised to take out Cancellation Insurance (see below).

### ESSENTIALS FOR PASSENGERS

Passengers are strongly advised to bring waterproof clothing; non-slip shoes or plimsolls; and a torch.

### HIRING CHARGE

is £100 per person per week, with a minimum charge of £500 per week. A £100 booking deposit should accompany the application to hire, with the balance payable six weeks before the holiday date. Please note that a security deposit of £50 is also payable with the booking deposit (see Conditions of Hire). No application will be accepted without a brief note from the ill/disabled passenger's General Practitioner. In the event of cancellation, the booking deposit will not be refundable.

**N.B. It is the responsibility of the hirer to ensure that adequate cancellation insurance cover is taken out.**

**PLEASE NOTE THERE MUST BE A MINIMUM OF TWO ABLE-BODIED ADULTS IN THE GROUP**

**“MELODY” - CONDITIONS OF HIRE**

- 1) Navigation – it is strictly forbidden to tow another boat, travel after dark, or navigate any tidal waters without prior written permission of the Trust. The Hirer shall at all times comply with instructions given by the Trust or Waterways Authorities.
- 2) Availability of craft – if, due to circumstances beyond its reasonable control, the Trust is unable to provide the Hirer with the boat booked, the Trust will refund all hire charges paid in full but the Hirer shall have no further claims upon the Trust.
- 3) Return of the Boat – the boat must be returned at the end of the holiday in a clean condition and vacated at the agreed time and place. The Hirer is responsible for allowing sufficient margin of time for contingencies. The Trust reserves the right to claim upon the Hirer for any expenses in which it is involved, as a result of the late return or any necessary extra cleaning.
- 4) The boat has sufficient diesel fuel for a minimum of one week's cruising.
- 5) The Security Deposit of £50, payable with the initial booking deposit, will be returned to you by cheque after your holiday, less any deductions in respect of loss or damage, late return or any abnormal cleaning required.
- 6) Bookings will not be accepted from prospective hirers of under 20 years of age.
- 7) Breakdowns – the Hirer shall have no claims upon the Trust as a result of any breakdown or failure of the boat, its engine or equipment. However, the Trust will make every effort to rectify the breakdown/fault with all speed after it has been reported. Where such a breakdown is caused by the negligence of the Hirer, the Trust shall have the right to claim upon the Hirer in respect of expenses involved in rectifying the matter.
- 8) Hirer's Property – the Trust accepts no liability for loss or damage to the Hirer's property whilst on the boat or the premises of the Trust, howsoever caused.
- 9) Restricted Cruise – the Trust accepts no liability and shall not be bound to make any financial adjustment in the event of normal cruising waters being restricted through repair, floods, drought or fuel becoming restricted or rationed or any other cause beyond the control of the Trust. In the event of cruising being impossible, the boat shall be treated as a moored houseboat and the hire charge shall be reduced by one third.

**“MELODY” - CONDITIONS OF HIRE (Contd.)**

- 10) Instruction – the boat will not be allowed out to the Hirer until instruction has been given and the Trust is satisfied as to the Hirer’s competence. If competence by the Hirer cannot be demonstrated, the Trust reserves the right to cancel the booking and refund all hire charges paid in full or have the boat treated as a moored houseboat and reduce the hire charge by one third. In either case the Hirer shall have no further claims upon the Trust.
  
- 11) Waterway Rules – any breach of the Waterway Authorities’ Rules and Regulations will mean termination of the Hire Contract by the Trust.
  
- 12) Accidents – the Hirer must report immediately by telephone to the Trust any accident to the boat or its equipment or to waterways property, whether or not other boats are involved, and shall then proceed as instructed by them. The Hirer shall not at any time admit to any liability for any accident to any third party and shall not put any repairs into the hands of any person or company without the Trust’s consent.
  
- 13) The Hirer undertakes to report, and may be requested to pay for, any equipment lost, broken, stolen or damaged. Unsuitable substitutes will not be acceptable.
